Ladies:

This letter will acknowledge receipt and acceptance of your 2010 Connecticut Women's Amateur Championship application. The Championship will be conducted at the Oronoque Country Club Course, 385 Oronoque Lane, Stratford, Ct. 06614 on August 10 through 12, 2010.

We cannot over emphasize the need to allow extra time to reach the course as the morning traffic in the area is generally very heavy.

**Following are items of information concerning this tournament and are part of the conditions of the competitions:**

**FORMAT:** 54 hole individual stroke play. The Champion will be determined by the low 54 hole score. In the event of a tie, the Champion will be determined by a hole-by-hole playoff immediately following play. Holes 10, 11 and 12 will be played in sequence until a Champion is determined.

**REGISTRATION:** When you arrive at the club, check in at the reception table, located outside the restaurant.

**LOCKER ROOM:** The locker room, located in clubhouse, will be open for your use at 6:30 a.m.

**TRANSPORT OF PLAYERS CLUBS:** Paying for a golf cart is mandatory (cost is not included in the entry fee). Players may walk with clubs, have a caddie or ride in a cart. There will be a limit of two carts per group.

**FOOTWEAR:** It is a condition of this competition that shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition: **DISQUALIFICATION.**

**PRACTICE ROUNDS:** Are available by calling (203) 377-6307. Greens fees are \$39 including cart.

**PRACTICE RANGE:** The range will be open at 6:30 a.m.

**On Course BATHROOMS:** Port-o-lets are located on the 5<sup>th</sup> hole, left side between tee and green and beside the 13<sup>th</sup> green.

**DISTANCE MEASURING DEVICES:** Devices that measure distance only will be permitted. See The Rules of Golf, Appendix I, Part B, Section 9 for the requirements.

**WATER STATIONS:** There are permanent water stations at the end of the 3rd, 6th, 13<sup>th</sup> and 16th holes. Coolers of water will be on the first and tenth tee.

**FOOD & BEVERAGE:** A continental breakfast will be available for contestants at no charge; cooked breakfast will be available for purchase. Lunch and snacks will be available at the restaurant located in the clubhouse. If you purchase something at the turn do so quickly so you do not get behind time or out of position.

**CELLULAR PHONES:** Use of a cellular phone or similar device by a contestant during the stipulated round is strictly **PROHIBITED**.

**DRESS CODE:** Contestants are required to adhere to the following guidelines:

- Shorts must be Bermuda length
- Shirts must have collars or sleeves
- Jeans are not allowed
- Hats must be worn in a traditional manner

**DIRECTIONS: From North:** Take CT-15 S (Wilbur Cross/Merritt) to Exit 53. Turn right at end of ramp. At 3<sup>rd</sup> light turn left onto Oronoque Lane. Pass 1 stop sign. Club entrance will be on left.

**From Eastern CT:** Take I-95S to Exit 38. Stay in the left lane and take Merritt Parkway South to Exit 53. Follow direction above.

**From lower Fairfield County;** Take I-15N (Merritt Parkway) to exit 53. Turn left at end of ramp. At 3<sup>rd</sup> light turn left on to Oronoque Lane. Follow directions above.
